The Electoral Commission of Zambia now invites bids for the Supply, Delivery and Installation of Six (6 No.) Network Switches at the Electoral Commission of Zambia.

Bidding will be conducted through open national bidding (ONB) procedures specified in the Public Procurement Act No. 8 of 2020 as amended by Act No. 17 of 2023 and the Public Procurement Regulations of 2022 and is restricted to **eligible citizen and local bidders**. The terms citizen and local bidder are defined in the Public Procurement Act No. 8 of 2020 as amended by Act No. 17 of 2023.
